# **Read and Accept Report**

#### Overview

Data on which employees have engaged and read your organization's Safety Program and Safe Work Practices is important to Managers and Administrators. The Read and Accept report will provide Managers and Admin users of the platform insight into which users have read and accepted the various segments of the Safety Program and Safe Work Practices to give you a better overall picture of which areas may need work.

# Step 1

Log in to www.inunison.io and click "Reports".

# Step 2

On the "Choose a Report" screen, click Safety Program Read Report.
